President Grabe called the meeting to order at 5:18 p.m. at the School District Office noting Mr. Con will chair the meeting in the absence of Mr. Madden.

Open Session

President Grabe called the meeting back into Open Session at 6:30 p.m. All present participated in a Moment of Silence and the Pledge of Allegiance.

Open Session

President Grabe reported no action was taken during the Closed Session. Mr. Con noted the revisions to the agenda made during the adoption of the agenda.

Cory Butcher, Student Representative, Big Bear High School was absent from the meeting this evening.

Student Rep. Report

Tyler Fries, Student Representative, Chautauqua High School reported teachers participated in a webinar with Naviance. Naviance will be considered as an option next year for career development. Students will test to see if this might be a good path for CTHS. A representative from the Career Center will be meeting with CTHS graduating seniors. Scholarship forms were filled out by all students in the district last week. Ham Radio operators will be meeting with Ms. Ugo regarding volunteering in an electronics program at CTHS.

Hale Obernolte spoke on behalf of the Big Bear High School and Big Bear Middle School Odyssey of the Mind Students. Hale has been involved in this program for seven years; on a team for six years. Troy Obernolte has been on a team for six years. An explanation was provided regarding Odyssey of the Mind and the creative thinking competitions involved. There is no right answer; it is very open ended. Teams were introduced to the Governing Board. President Grabe presented certificates to Mrs. Ricuitti and Mrs. Obernolte in recognition of both teams.

Recognition Section

Mrs. McLinn, Principal, North Shore Elementary School introduced Mrs. Robin O'Hare and explained the Fine Arts Program at North Shore and how the program was started. President Grabe presented a certificate to Mrs. Robin O'Hare for her dedication to the Fine Arts Program at North Shore and all students in attendance were recognized by the Governing Board.

President Grabe opened the Hearing Section for Public Comment at 6:57 p.m. Hearing no request to make Public Comment, President Grabe closed the Hearing Section at 6:58 p.m.

Public Comment

Mr. Con introduced Mrs. Crawford and Mr. Cacace from Siemens Industry, Inc. and explained the relationship the district has with Siemens. Mr. Con reviewed the reduce and produce programs. Mr. Cacace, Project Manager, reviewed safety which is one of their major concerns. Fencing was reviewed and it was noted all personnel on the construction sites receive a live scan background check. Mr. Cacace is on construction sites Tuesdays through

Thursdays. There is an onsite superintendent available when Mr. Cacace is not on site. Mr. Cacace checks in daily with principals and the assistant principal at the high school. Mr. Cacace reviewed site spec plans with dates and explained the construction process specifically the depth of the piers and the steel columns. Siemens continues to work closely with Bear Valley Electric Service through this process. The fencing layout maps were reviewed and Mr. Con noted the high degree of safety on each of these sites during construction. Communication is continuous with principals. Temporary evacuation plans will be created with the architect where necessary. Mr. Planz and Mrs. Callaway have been key in the coordination of these jobs.

Mr. Con reviewed key items listed on the calendar. Mr. Con explained the request to name the district board room after Dr. Turney and also shared the process to address this request. Mr. Con reviewed AR 7310-Naming Facilities and BP 1220-Community Relations. A committee will be formed to make a recommendation to the Governing Board. A consensus was reached by the Governing Board to move forward and form a Facility Naming Committee to consider the request to name the district board room after Dr. Turney.

Information Section

Mr. Con reviewed the monthly performance indicators noting 198 classroom visits which is lower due to the testing and other administrator responsibilities as well as spring break. Ten suspensions; two visits by law enforcement; 2615 technology devices in the district. No updates were provided on professional development or participation in the breakfast and lunch programs.

Mrs. Herrick reported on the STEM event at BBMS and stated this was a great Board event and continues to highlight what STEM is about. Mrs. Herrick also attended Member the Odyssey of the Mind fundraiser. Reports

Mr. Goepp also attended the "STEAM" Night at BBMS noting the presentations by elementary schools.

Mr. Zamoyta noted his son has been lucky to participate in Mrs. O'Hare's program and commented on the many awards won by these groups. The students and parents have tremendous spirit and represent Big Bear well. President Grabe attended STEM Night at BBMS. President Grabe announced the Governing Board is now visiting school sites rather than the sites coming to board meetings. This week is Teacher Appreciation Week; President Grabe extended appreciation to all people working in education. President Grabe reported on her attendance at the breakfast hosted by the Transportation Department to recognize bus drivers. President Grabe also attended the Hope of America Awards held at the PAC.

Dr. Foulkes did not have any reports to offer.

Mrs. Fulmer congratulated BBMS for receiving a Gold Ribbon Award. Art Teacher interviews were held; Mrs. Fulmer explained the interview process. On the agenda for the May 20, 2015 board meeting, a name will be presented for the Art Teacher position at the high school.
