Dr. Waner explained the process for the reclassification of students. The Cabinet criteria have been revised and we are looking at students who have passed the CELDT. If students are no longer EL students, they are able to take elective classes. CALPADS is being reviewed and we will be able to classify EL students.

At 6:54 p.m., President Foulkes reopened the Hearing Section in order for Ms. Michelle Morgan to address the Governing Board. Ms. Morgan stated she has several concerns; noting she has been a resident of Big Bear for three years and a resident of Forest Falls for seven years. She is concerned with the new superintendent, with the way she was treated when she applied for a position, she was told she was not qualified for the position she applied for, and she accused the district of labeling her and losing her file. President Foulkes closed the Hearing Section at 6:58 p.m.

Mrs. Rosado provided an update on Prop 39. In order to have a board approved plan, the district must go out to bid; we plan to utilize Planet Bids for this process. An item will be on the August 17, 2016 board agenda regarding the \$480,000.00 awarded to the district. Additionally, the bond refunding will be placed on the August 17, 2016 board agenda.
