President Goepp called the meeting to order at 4:00 p.m. at the School District Office.

President Goepp called for Public Comment on Closed Session items. Hearing no request to make public comment, President Goepp adjourned the meeting to a Closed Session at 4:01 p.m.

President Goepp called the meeting back to Open Session at 5:30 p.m.

Open Session

All present participated in a Moment of Silence and the Pledge of Allegiance.

President Goepp reported the following action was taken during the Closed Session: The Governing Board approved in Closed Session by a unanimous roll call vote-all Governing Board Members present-to approve a settlement agreement with Employee Number 2018-2019-002. Upon approval of the settlement agreement, Employee Number 2018-2019-002 resigned in lieu of termination. The terms of the settlement agreement allows this employee to receive his/her regular salary through December 31, 2018 and BVUSD will continue to pay the employer portion of his/her health and welfare benefits through December 31, 2018. Total cost to the district is \$7,247.00.

Kailey Jonasson, Student Board Representative, Chautauqua High School reported on Red Ribbon Week and Spirit Week activities which took place at Chautauqua High School. Kailey also reported on Field Day activities which included a tricycle race using specific googles to simulate being drunk. Kailey also provided information on early graduates form Chautauqua High School. Chautauqua will again, host a traditional Thanksgiving feast. Students at Chautauqua are being encouraged to co-enroll in San Bernardino Valley College Classes. Kailey reported Thinking Maps are being worked into the curriculum; Kailey shared some examples of how she is utilizing Thinking Maps in her classwork. Kailey provided a report on Fallsvale Elementary School noting 70 students now attend Fallsvale. 100% of parents and guardians attended the parent/teacher conferences. Staff at Fallsvale have started learning and implementing Thinking Maps. The first school costume dance was held at the Community Center. A community food drive will start next week at Fallsvale. Fallsvale staff wished to thank the Governing Board for the support

Student Rep. Report and dedication to the students and families of the Forest Falls Community.

Leliah Navarrete, Student Board Representative, Big Bear High School provided a report on Baldwin Lane Elementary School and the art work being created at Baldwin Lane. Thinking Maps are also being implemented at Baldwin Lane. Leliah reported the first-grade students from Baldwin Lane visited the fire station and learned about fire safety. Leliah also reported on a Mother/Son Dance held at Baldwin Lane. Leliah reported on a high school financial aid meeting held to help students and parents understand how financial aid works and how to apply for financial aid. Hunter Natsic explained the Days of Understanding activity scheduled at Big Bear High School on November 8th and 9th. On November 8th, the entire school will participate in an assembly. On November 9th, the Juniors and Seniors will facilitate with the Sophomores. Leliah provided reports on the Fall sport activities noting the Winter sports have started practices. Leliah provided a report on the club activities taking place at Big Bear High School and invited the Governing Board to Open Mic Night scheduled on November 30th.

Ms. Newton introduced Ms. Cynthia Britt, School Psychologist. Ms. Britt presented information on a study that will lead into her dissertation. Dr. McReynolds, dissertation Staff Press. chair, provided an overview of what neurofeedback consists of. A short video was presented which explained further what neurofeedback is. Dr. McReynolds reviewed how clients performed better across all tests after 40 sessions; what they find is 80% of people have something going on with auditory and visual processing. Once the brain learns, it still remembers; the brain has learned how to do something. Ms. Britt reviewed charts of visual and auditory and how the scores improved through the neurfeedback session. Ms. Britt reviewed her study and how it would serve as an additional form of support to students. Neurofeedback could be a way to build RTI once students are referred to Special Education. It was noted Dr. McReynolds will be loaning all equipment necessary for this study to BVUSD for this program by Ms. Britt.

Dr. Suzuki introduced Ms. Lucinda Newton, Executive Director TK-5 Curriculum and Instruction/Student Services. Ms. Newton presented information on alternative means of correction as of quarter one. Ms. Newton reviewed why we should use alternatives means of correction; alternatives to suspension can be much more effective in getting student's behavior to change. Ms. Newton reviewed when alternatives means of correction should be used. Ms. Newton presented 2016-2017 data from the California

Community/

Dash Board. BVUSD's Leadership Team is reading the book Better than Carrots and Sticks; principals and cabinet members are reading and discussing this book during Leadership Team Meetings. We are beginning to look at sharing ideas to build better practices such as expect respect, PBOS, Restorative Justice, Counseling including alcohol/drug program, academic supports, community service, and Behavior Intervention Plans (BIPS). Ms. Newton recognized principals and Ms. Britt for their hard work with our special education students and the reduction of suspensions. Ms. Newton explained how we are measuring success. Ms. Newton reviewed the Expect-Respect Program at BBMS. Infinite Campus and Youth Truth data will be available in February of 2019. Ms. Newton reviewed next steps including the next two meetings of the Positive Climate Committee.
