Dr. Suzuki noted we are receiving great feedback from parents on the survey we sent out. Dr. Suzuki reviewed some of the possible scenarios. We have a draft of a Reopen Plan. Dr. Suzuki reviewed discussions that are taking place and we will be meeting with the Associations for their input. We met with Leadership Team and we will be meeting with Management Team. We will also be meeting with teachers and a Parent Advisory Committee to get their input to the plan. We will also have the results of the survey.

Mr. Zamoyta reported on joining the School Services presentation of the Governor's May Revise. Mr. Zamoyta noted one hope is the HEROS Act which would mean the majority of the cuts would be wiped out. He does not know the likeliness of that passing. Mr. Zamoyta asked if anyone has had issues with the AP test online. Dr. Waner answered AP US History was one essay due in 45 minutes. There were no issues with English and the submission of that essay. Other tests have had issues submitting information. It is still a timed test and students are able to utilize notes, etc.

Board Member Reports

Dr. Foulkes provided an update on the Education Foundation. During a meeting held last week, the Foundation approved a contract with Southern California Mountains Foundation to start building the trails. This should start next week. Also approved was a contract with Hicks and Hartwick for design and engineering for community fields. This will have to go to the County for approval. Mr. Goepp made a presentation on the aquatic center and what it could be. The Foundation is working on finalizing their website; they did finalize the logo. They are not sure how many volunteers they will get due to COVID-19.

President Herrick reported on her participation in the Governor's May Revise presentation noting the Legislative Analyzers are stating it is based on us now being in a recession. President Herrick noted the Joyful Noise Car Parade was great and it was nice to see the District staff and the decorated bus at Big Bear Middle School. 150 cars participated in the parade.

President Herrick called for approval of the Business/Financial Report.

Mrs. Rosado explained the differences in the bids received noting PaveWest typically comes in under budget. Bids are usually scattered; sometimes not as much as these bids. Mrs. Rosado noted past experience with PaveWest has been favorable.
