Dr. Suzuki reported the district welcomed second and third grade students back on campuses noting teachers are working hard on streaming. Dr. Suzuki commended teachers, staff, and principals for working with staff on dual screens and iPads. Teachers are working with distance learning in the afternoons. Overall, we did not have any issues with the internet. Teachers are working hours to support students at home and at school. Students attend 8:00 a.m. to 12:30 p.m. and take their lunch home. There are eight to twelve students in a class; fourteen is the most in a class. Cohorts are attending at Big Bear Middle School and Big Bear High School. Dr. Suzuki noted there are no cases of transmission that can be contact traced back to our schools since September 26, 2020. Dr. Suzuki is reviewing research which says schools tend to not be hot spots. Dr. Suzuki noted sports conditioning is occurring. Dr. Suzuki stated there is an increase in cases in the Valley. We want to be sure campuses are spread out and fully distanced. Fourth and fifth grades will not be brought back at this time for safety purposes; we will continue to watch the data. Dr. Suzuki commended, the staff, custodial staff, classified staff, and teachers for helping students stay safe. Dr. Suzuki noted the students are very compliant and they are thrilled to be back with their friends.
