#### 1. Call to Order Open Session

Mr. Zamoyta called the meeting to order at 5:30 p.m. noting this meeting is being audio recorded.

#### 3. All present participated in a Moment of Silence and the Pledge of Allegiance.

#### 4. Community-Staff Presentations

a. Beatrice Blake, Coordinator, and Addison Saenz, Reaching the Whole Child, San Bernardino County Superintendent of Schools

Ms. Blake and Mr. Saenz presented a certificate plaque to Bear Valley Unified School District recognizing the district's tobacco free certification by the California Department of Education (CDE), on behalf of the San Bernardino County Superintendent of Schools, Ted Alejandre. Ms. Blake expressed her appreciation for the district's continued

partnership with the San Bernardino Superintendent of Schools Tobacco-Use Prevention Education (TUPE) consortium. Mr. Saenz presented information on TUPE, the youth vaping epidemic, cessation programs through TUPE, and shared information on their new video game "BeatNic Blvd." that promotes tobacco use prevention and education for students. Mr. Saenz thanked Mr. Sean Young for his dedication and the vital role he plays in the overall success of the program and BVUSD for their continued partnership with the TUPE program.

# b. Lease-Purchase Financing for the Big Bear High School Sports Field and Refinancing of the 2013 Certificate of Participation of Dept Service

Mr. Keith Weaver of Government Financial Strategies presented information on the Lease-Purchase financing for the Big Bear High School Sports Field and the refinancing of the 2013 Certificate of Participation Dept Service. Mr. Weaver shared that Government Financial Strategies acts as a fiduciary to the district, that they are independent, not affiliated with banks or lenders, and they are regulated by the Securities and Exchange Commission. Mr. Weaver's presentation included information for the financing of the new sports field and refinancing of old debt. Through the Request for Proposal (RFP) process, it was determined that Sterling Bank is the best option. The finance amount will be \$8,826,006 at 2.52% fixed rate, with a rate lock until closing. This fixed rate will save the district about \$688,000 over the life of the loan. If the Governing Board approves this option the financing would be completed by October 27, 2021.

#### 5. **Hearing Section**

#### a. Public Comment

Mr. Zamoyta reviewed the Quick Summary/Abstract for Public Comment.

**Nicole Cheek** – Mrs. Cheek stated that she understands the board cannot go against the law but asked for the board members' support in standing up to the state legislators against mandated vaccines. She stated she is not against the vaccine but is for personal rights. Mrs. Cheek also requested that the district conduct a survey of families to see who will leave the state if the vaccine is mandated and see what the financial impact would be and how it would affect programs/students.

**Michael Cox** – Mr. Cox stated that he is the parent of three BVUSD students. Mr. Cox shared that he has had a wonderful experience in at both Big Bear Middle School and North Shore Elementary School. Mr. Cox expressed his frustration with Governor Newsom's vaccine mandate and understands that this is not coming from the district level. He shared it should be known at all levels that prohibiting students from attending in class learning is detrimental to our kids and community. Mr. Cox stated that forcing students who do not get the vaccine into distance learning is not equitable. Mr. Cox urged the Governing Board to do what is best for students, fight for medical freedom and vaccine choice.

#### b. Notice of Proposed Maps for Trustee Area Elections

Mr. Todd Robins, Partner of Atkinson, Andelson, Loya, Rudd & Romo presented a review of the California Voting Rights Act of 2001, which questions the at-large election process that could be used in some areas to dilute the voting strength of voters of protected classes. In order to avoid potential litigation, this district would need to transition to by-trustee area

election. Mr. Robbins shared that 2022 would be the first by-trustee area election. The district has had two pre-map public hearings required by the statute. Mr. Robins explained the process of moving to by-trustee area elections. There was discussion about the merits of by-trustee area elections in the Big Bear Valley, the concept of dilution of protected class votes, and the possibility of challenging this statute.

Angela Vanjuelos of Cooperative Strategies shared information on the timeline and creation process of three draft maps drawn to comply with the California Voting Rights Act. Each map was reviewed with information on the Citizen Voting Age Population (CVAP) variances. After extensive discussion, it was decided to use scenario three with adjustments according to feedback given by the Governing Board. Ms. Vanjuelos stated she would provide two additional maps at the next board meeting, which show school boundaries and different communities within the district. The Governing Board members requested an overlay with CVAP information, clear street divisions, and street names. These scenarios will be brought back to the Governing Board at the November 3, 2021 Board Meeting. Mr. Zamoyta called for public comment on this agenda item. Hearing none, he moved on to the Consent Calendar.

Dr. Suzuki reported that our California Basic Educational Data System (CBEDS) enrollment was reported at 2,162. The district's projection was 2,130.
