1. Call to Order Open Session

President Zamoyta called the meeting to order at 5:30 p.m., noting this meeting is being audio recorded.

3. All present participated in a Moment of Silence and the Pledge of Allegiance.

4. Community-Staff Presentations

a. Presentation of the Draft of the Big Bear High School Landscape Plan

Mrs. Linda Rosado, Executive Director of Business Services and Classified Personnel, presented a draft of the Big Bear High School (BBHS) Landscape Plan. This plan was developed with input received from Mrs. Tina Fulmer, Principal of BBHS, and Mr. Brian Willemse, Assistant Principal of BBHS. The landscape plan showed the proposed expansion of patios in front of the cafeteria and library, additional fencing, drought-tolerant trees, and some hardscape. Mrs. Rosado stated the original cost of the project was approximately \$100,000. Due to inflation, we

believe the cost could be between \$200,000 to \$300,000. Mrs. Rosado is seeking board input before going out for bid on this project. Discussion included the use of drought-tolerant plants, plants to prevent erosion, irrigation systems to ensure the plantings survive, curb appeal, possible partnership with forest service, obtaining input from local landscapers.

5. CDPH/CDC COVID-19 Updates and Survey Results

Dr. Mary Suzuki, Superintendent of Schools, provided a detailed review of the results of the COVID-19 Parents, Staff, and Community Survey. These results have been posted on the Bear Valley Unified School District (BVUSD) website with links to the California Department of Public Health. Dr. Suzuki expressed her gratitude to everyone who took part in this survey. Dr. Suzuki encouraged parents to contact their State Legislators to let them know their opinions. Contact information for various State Legislative offices can be found on the BVUSD website. Dr. Suzuki read a statement from CDPH regarding the differences in policy between vaccinated and unvaccinated individuals' quarantine. There was a discussion about the number of COVID cases having dropped last week. There was discussion amongst the Governing Board about the number of students who say they will move out of State or remove their children from the school district if Senator Pan's legislation regarding a vaccine mandate passes without personal exemptions. The Governing Board discussed drafting another letter to the Governor advocating for vaccine exemptions for students and staff, with the need to stress the adverse effects a vaccine mandate will have on our school district. Board members will submit bullet points to Dr. Suzuki by February 8th so that she and President Zamoyta can formulate a letter to be presented at the February 16th board meeting.
