#### 8. Hearing Section

#### a. Public Comment

Mr. Zamoyta read a letter for public comment sent by Nancy Haldeman.

#### Dear Governing Board Members:

I'm unable to attend due to prior engagements this evening, so I appreciate the opportunity to voice my concerns with you.

I have concerns on the content coming out of the Middle School. I'm not entirely sure who is deciding on the spirt week themes, but their content is not age appropriate in my opinion and there are other parents that agree with me on this.

I'm disappointed in the spirit weeks that are being encouraged at the Middle School for both the Valentine's week and the week of March 14. In regard to the Valentine's spirit week it was really only Tuesday of the week that was concerning as it was asking the kids to wear a specific color to validate their relationship status. I find this inappropriate for the age of these children. We shouldn't be promoting relationships in this manner at their ages.

For the week of March 14 all of the topics require more in-depth conversations, and my 7th grader didn't know what these topics were when I asked him about the spirit themes. There has been no education on these topics and now they are being asked to support them in school. Based on my knowledge these topics were conveyed in some form over the loudspeaker during class.

I'm not sure to the extent as my son said it was difficult to hear, regardless these topics shouldn't be broadcast over the loudspeakers at school.

Also, I've heard some disturbing news over the past few weeks of things happening on the middle school campus and while I understand there are privacy laws, are parents not notified of anything causing the Sheriff's department to be bought to campus? As a parent seeing the Sherriff's department on campus makes me wonder what is happening there and if there is enough supervision. Are they safe? Should I pull them out of school? These are thoughts that have crossed my mind and have me considering what happens with my children in the future.

I'm not naïve to think nothing bad will happen on campus, but something needs to change as it doesn't seem that the Middle School is promoting a safe and healthy environment for all students.

# a. Superintendent Comments/Calendar

**Dr. Suzuki** discussed site visits and how wonderful it is to see student faces and their joy as they walk into school. Dr. Suzuki reported on upcoming events happening within the District, such as April 9, 2022 - BBHS Prom at March Air Field and Museum and Open House events at the school sites.

## **b.** Governing Board Member Reports

**Dr. Foulkes** shared information about his new social studies curriculum review, particularly the sixth and 11<sup>th</sup>-grade editions. He stated that he was pleasantly surprised at the balanced presentation of specific events. Dr. Suzuki shared that the public viewing of the curriculum begins tomorrow. If members of the public cannot come during the viewing time, call the District Office, and we will make arrangements for you. Dr. Waner stated that she would check with the publisher to see if the links could be shared with the public. Discussion continued regarding the differences between U.S., World History, and Government Economics curriculum Mr. Roberts expressed that he has some concerns about what is going on at Big Bear Middle School, similarly aligned with the letter Mrs. Haldeman wrote. Mr. Roberts stated he knows Dr. Suzuki and the staff will address, but those concerns need to be handled pretty quickly. **President Zamoyta** discussed the Big Bear High School performance of Lillies of the Field. He shared that the performance by students was outstanding, on par with the movie. He also enjoyed the discussion with the performers and comments by students at the end of the performance. President Zamoyta commented on the retirement of Mr. Brian Adams, director of the BBHS Performing Arts Department, and how several people expressed their hope that we can find a replacement as good. President Zamoyta also spoke about an article in the Journal of the American Medical Association (JAMA), citing a study on children's mental health, the 27% rise in anxiety and depression and 50% increase in female students attempted suicide. President Zamoyta spoke about the increase in counseling staff for the district and requested a report from the counseling staff.
